### Introduction

The Marvel committee is directly affiliated with the S.H.I.E.L.D organization (The Homologated Intelligence, Espionage, Logistics, and Defense System) is an extra-governmental military intelligence and counterterrorism agency in charge of protecting all individuals around the world, including those without special powers. The agency has the best agents and most advanced weapons in the world, making it the greatest military power on Earth.

The committee is created with the purpose of protecting a man from himself, from an alien invasion, or from individuals who do not use their powers for good. The organization has a worldwide scope, both operational and legal, and most democratic countries are in support of S.H.I.E.L.D actions. Including the fact that most of these actions and activities are confidential, the public perceives them as covert, but their existence is not hidden from society.

This organization and our committee have already produced and directed projects for different crises in the world. One of the most important projects is Avengers (a group of extraordinary individuals who were formed to resolve various global conflicts and to protect society from supernatural evils. Conformed by Captain America, The Hulk, Ironman, Black widow, Thor and Hawkeye.

Marvel has taken part in numerous missions, either alone or in collaboration with other government organizations from the United States, S.H.I.E.L.D organization and other countries, all while adhering to official directives because it is not allowed to work on any projects without prior approval from the UN, the UN Security Council, or the World Defense Department. Our primary focus is on higher-level threats against people or entities that are not under our control.

When the Avengers first came together, they were a collection of extraordinary people who had been assembled in New York City to combat Loki and his army.

Since then, under the direction of the S.H.I.E.L.D organization, the Avengers have grown and encountered numerous adversaries.

#### Development

The regulation of superpowers is the primary crisis our committee is working to resolve. People are becoming out of control, endangering society and the entire planet. Our agency has already engaged in conflict with superpowers that were attempting to rule or wipe over Earth.

In 2012, after Loki, Thor's younger brother, led an invasion to reclaim the tesseract, Thanos was prompted to send an alien fleet to accomplish the same goal. As a result, New York City was severely damaged. When the society and civilians saw the new S.H.I.E.L.D. project, the Avengers, this led many to start doubting and criticizing his superpowers as well as the protection he received from the government.

After the New York incident, another catastrophe occurred in 2015 called the Battle of Sokovia. Ultron, one of Ironman's failed projects, caused almost the complete extinction of the planet. However, thanks to the Avengers, the enemy's goal was foiled, but there were many unintended consequences, including the deaths of 200 people and the loss of more than 400 billion dollars.

In order to take control of this perilous scenario, the government is requesting action. The Sokovia Accord was one of our main documents and treaties. This involved managing, directing, and overseeing the actions of enhanced people, including agents of S.H.I.E.L.D. and other organizations. More than a hundred nations ratified this United Nations-created pact in 2016. This agreement was created as a formal response to growing concern on a global scale about the activities and effects of hazardous people, in the intention of reducing field casualties and halting the frequent widespread devastation.

Nick Fury, Maria Hill questioned the effectiveness of the regulation of enhanced individuals, as it seemed a purely political proposal made without taking into account the feasibility and effectiveness of this, many organizations related to this type of activities have also doubted such governmental agreement.

A clear example of the dissatisfaction of the organizations was Daisy Johnson, an individual who began to act as a threat, and her activity made some people question the effectiveness of the Sokovia Accords.

At the Vienna International Center in Austria, the UN organized a ceremony for the ratification of the agreements of Sokovia. Black Widow, King T'Chaka of Wakanda, whose nation is crucial to S.H.I.E.L.D. for weaponry and security, and his son T'Challa was in attendance. A bomb went off during the opening remarks, killing an amount of delegates, including the monarch of Wakanda. Many had their worries regarding the government's authority over many unidentified organizations confirmed when this occurrence took place.

The Avengers association was split between those who supported and opposed the Sokovia accord. Captain America took the lead, followed by Hawkeye, Falcon, Scarlet Witch, and the Winter Soldier. These agents fiercely resisted the treaty, even turning against their own team.

The Sokovia Accords comprised a number of regulations, including:

- The United Nations requires improved, aka, enhanced people who give their permission and consent to sign to register and to publish biometric data, such as fingerprints and samples containing DNA.
- When they sign up, enhanced people are forbidden from operating outside of their own nation unless they first acquire permission from that nation's or the UN's leadership.
- Those who utilize their enhanced abilities to breach the law or pose a danger to public safety may be imprisoned without charge for an unlimited period of time.

Any person (human or not) with superhuman skills is an enhanced person, according to the Sokovia Accords. For instance, this covers both those who possess superhuman powers naturally and those who improve them with the aid of cutting-edge technology. Even if they are not improved, all Avengers members must abide by the conditions of the improved people.

# Conclusion

The countries affiliated with Marvel and S.H.I.E.L.D. are in favor of the government's and the Department of Defense's choice to protect and defend everyone, including those with special powers.

Many people in society are afraid of what may happen in upcoming events and More frequent attacks on the world and society are occurring. Society requires our assistance.

To sum up, our committee is searching for solutions, for people who can assist and safeguard the world, and for deeds that can help with the current crisis of superpowers beyond governmental control, like the Sokovia pact.

Furthermore, our organization recommends creating solutions in the most peaceful way possible, to avoid conflict between government foundations and superheroes from different groups such as avengers, and individuals around the world with giftedness do not feel the government as a threat but as an ally and protection.

Some of these solutions can be treaties or actions including projects to comply with governmental requirements for the regulation of the correct use of superpowers, set limits and even make alliances with other organizations for the creation and procedure of the kind solution.
